Bryan Muecke and Ray Crosby-Willis have been working on insurance coverage applications since GuideOne told us they would not renew our policy. At this point, we have continuing coverage with GuideOne (expensive) while we are getting Brotherhood, at which point we will cancel the GuideOne policy and move to them.

Since the last meeting, we have, in fact received significant contributions from congregations, which definitely helps. It appears there has been more in January for 2024. We also received a \$35k per capita bill from Louisville, which we will pay quarterly. We prepaid our Synod per capita for the discount. Our working balances remain narrow. Our year-round payroll is approximately \$6k per month. We still have a credit with the Board of Pension for a now-corrected error in the past.

I have been in contact with the Mission and Witness Committee, who wanted reassurance that this year they will be able to grant their budgeted mission funds. I believe they will be able to, and they will be doing their grants on a more staggered basis than 2024, which will help.

The hearing on the workplace harassment case from several years ago has finally been scheduled. Our attorney, Carl Steinbrenner, is representing us and discussing options with several of us in leadership roles. We have another legal bill for an annoying matter concerning the Lodi sale.

Our online donation page is up and running with several categories as suggested by Council. Go to <u>https://secure.myvanco.com/L-ZBHC/home</u>. We need to publicize it widely.

Plans are being made for the 2024 audit with Heveron.
